Section 13-1-010 Utah Criminal Code. The Utah Criminal Code set forth at Utah Code Annotated § 76-1-101, et seq., as amended, is hereby adopted as the Criminal Code of Draper City.

Section 13-1-020 Utah Code of Criminal Procedure. The Utah Code of Criminal Procedure as set forth at Utah Code Ann. § 77-1-1, et seq., as amended, is hereby adopted as the Code of Criminal Procedure of Draper City.

Section 13-1-030 Utah Controlled Substances Act. The Utah Controlled Substances Act as set forth at Utah Code Ann. § 58-37-1, et seq., as amended, is hereby adopted as the Controlled Substance Act of Draper City.

Section 13-1-040 Utah Drug Paraphernalia Act. The Utah Drug Paraphernalia Act as set forth at Utah Code Ann. § 58-37a-1, et seq., as amended, is hereby adopted as the Imitation Controlled Substance Act of Draper City.

Section 13-1-050 Imitation Controlled Substances Act. The Imitation Controlled Substances Act as set forth at Utah Code Ann. § 58-37b-1, et seq., as amended, is hereby adopted as the Imitation Controlled Substance Act of Draper City.

Section 13-1-060 Alcoholic Beverage Control Act. The Alcoholic Beverage Control Act as set forth at Utah Code Ann. § 32A-12-101, et seq., as amended, is hereby adopted as the Alcoholic Beverage Control Act of Draper City.

Section 3-1-070 Limitations. Each of the Codes and Acts adopted herein are hereby adopted as if fully set forth at length, provided however, that any provision which is classified as a felony or a class A misdemeanor or which is not enforceable by Draper City under the laws of the State of Utah, is excluded.

Section 13-1-080 Omission not a Waiver. The omission to specify or enumerate in this Ordinance those provisions of general criminal law and offenses applicable to all cities shall not be construed as a waiver of the benefits and enforcement of any such provisions.

Section 13-1-090 Citation. For purposes of referring or citing to provisions of the Codes and Acts adopted herein, the specific provision of the Code or Act shall be cited by number preceded by Title 13 of the Draper City Code, e.g. 13/76-1-101.

Section 13-1-100 Rules of Construction. Insofar as possible, the provisions of this Title and the Codes and Acts adopted herein shall be construed in a manner to ensure the enforcement of the criminal laws of the State of Utah. In the event any provisions are inconsistent, the inconsistency shall be resolved as follows:

(a) Any provision of this Title which was at one time, but is not now, consistent with the Codes and Acts adopted herein shall be controlled by the law as it is reflected in the most recent version of the Code or Act, as amended.

(b) Any provision of this Title which deals with the particular local needs and policies of Draper City and is otherwise lawful shall control.

Section 13-1-110 Copies of Codes. Three (3) copies of each of the Codes and Acts adopted herein shall be available in the City Recorder's Office for use and examination by the public.

Section 13-1-120 Penalties. Except as otherwise provided, any violation of this Title shall be a class B misdemeanor. This section shall not limit the authority of the Court to impose any other sanction or order any other relief as may be appropriate and lawful under the laws of the State of Utah.

Section 13-1-130 Fine Schedule. Fines for violations of this Title shall be assessed in accordance with the Uniform Fine Schedule as adopted and amended by the Judicial Council.
